### ‘The Rule of Six’

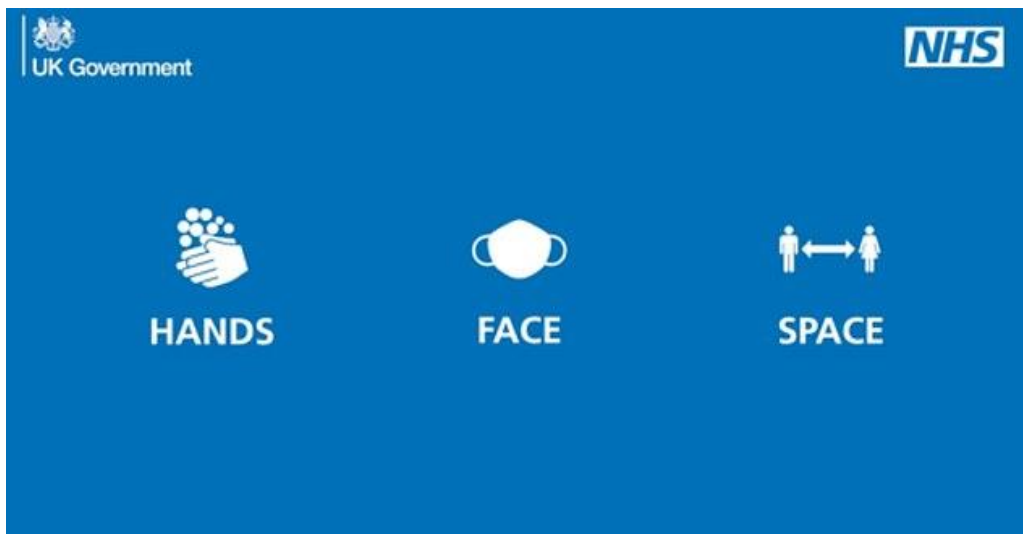
The Prime Minister led a [press briefing](#) on 9<sup>th</sup> September and explained that as a consequence of a steep rise in cases of COVID-19 cases social gatherings of more than six people in England will be banned by law with effect from Monday, 14<sup>th</sup> September. The new rules will ban larger groups meeting anywhere socially, indoors, or outdoors. It will not apply to places of work, schools, or COVID-secure weddings, funerals, and organised team sports.
